Notice Regarding Non-operating Expenses and Extraordinary Losses

Sharp Corporation ("the Company") announces the recording of the following non-operating expenses and extraordinary losses in the consolidated financial results for the third quarter of the fiscal year ending March 2025 (October 1, 2024 to December 31, 2024).

1. Details of non-operating expenses

Sharp Group ("the Group") recorded foreign exchange losses of 17,533 million yen as nonoperating expenses for the third quarter of the fiscal year ending March 2025 (October 1, 2024 to December 31, 2024).

Due to sales decline in Device Business, a part of contract liabilities (advances received) denominated in foreign currency became subject to revaluation by foreign currency exchange rate at the end of the third quarter, resulting in a major part of the foreign exchange losses.

2. Details of extraordinary losses

The Group recorded 17,295 million yen impairment losses and 8,818 million yen business restructuring expenses as extraordinary losses for the third quarter of the fiscal year ending March 2025 (October 1, 2024 to December 31, 2024).

These are primarily related to the impairment loss associated with Camera Module Business as well as the restructuring expense associated with the Sakai Plant.
